A BILL TO BE ENTITLED

AN ACT REVISING THE LAWS GOVERNING THE SUBMISSION OF ANNUAL REPORTS  
BY VARIOUS BUSINESS ENTITIES TO THE SECRETARY OF STATE.

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 55-16-22 reads as rewritten:

"§ 55-16-22. **Annual report.**

(a) Requirement. – Except as provided in ~~subsections (a1) and subsection~~ (a2) of this section, each domestic corporation and each foreign corporation authorized to transact business in this State shall ~~deliver~~ submit an annual report to the Secretary of Revenue in paper form or, in the alternative, directly to the Secretary of State in electronic form as prescribed by the Secretary of State under this section.

~~(a1) Each insurance company subject to the provisions of Chapter 58 of the General Statutes shall deliver an annual report to the Secretary of State.~~

(a2) Professional Corporations Exempt. – A domestic corporation governed by Chapter 55B of the General Statutes is exempt from this section.

(a3) Form; Required Information. – The annual report required by this section shall be in an electronic form ~~jointly~~ prescribed by the Secretary of Revenue and the Secretary of State. ~~The Secretary of Revenue shall provide the form needed to file an annual report. The State, and the Secretary of State shall prescribe the form needed to file an annual report electronically and shall provide this form by electronic means. The annual report shall set forth all of the following:~~

- (1) The name of the corporation and the state or country under whose law it is incorporated.
- (2) The street address, and the mailing address if different from the street address, of the registered office, the county in which its registered office is located, ~~and~~ the name and e-mail address of its registered agent at that office in this State, and a statement of any change of ~~such~~ the registered office or registered agent, ~~or both agent.~~
- (3) The address and telephone number of its principal office.
- (4) The names, titles, and physical business addresses of its principal ~~officers~~ officers and any other person who has actual authority to bind the corporation.
- ...
- (5) A brief description of the nature of its business.
- (6) A valid e-mail address for the corporation, if different from the e-mail address provided under subdivision (2) of this subsection.

1 ~~If the information contained in the most recently filed annual report has not changed, a~~  
2 ~~certification to that effect may be made instead of setting forth the information required by~~  
3 ~~subdivisions (2) through (5) of this subsection.~~

4 (b) Currency of Information. – Information in the annual report must be current as of the  
5 date the annual report is executed on behalf of the corporation.

6 (c) Due Date. – An annual report ~~eligible to be delivered to the Secretary of Revenue is~~  
7 ~~due by the due date for filing the corporation's income and franchise tax returns. An extension of~~  
8 ~~time to file a return is an extension of time to file an annual report. At the option of the filer, an~~  
9 ~~annual report may be filed directly with the Secretary of State in electronic form. An annual report~~  
10 ~~required to be delivered to the Secretary of State is due by the fifteenth day of the fourth month~~  
11 ~~following the close of the domestic or foreign corporation's fiscal year.~~

12 (d) Incomplete Information; Civil Penalty; Criminal Penalty. – If an annual report does not  
13 ~~contain the information required by this section, the Secretary of State shall promptly notify the~~  
14 ~~reporting domestic or foreign corporation in writing and return the report to it for correction.~~  
15 completely and accurately contain the information required under subdivisions (2) and (4) of  
16 subsection (a3) of this section, the Secretary of State may assess a penalty of two hundred fifty  
17 dollars (\$250.00). In addition, any person who willfully fails to completely and accurately provide  
18 the information required under subdivisions (2) and (4) of subsection (a3) of this section shall be  
19 punished the same as in G.S. 55D-18. If the report is corrected to contain the information required  
20 by this section and delivered submitted, with payment of any penalty assessed under this  
21 subsection, to the Secretary of State within 30 days after the effective date of notice, it is deemed  
22 to be timely filed.

23 (e) Amendments. – Amendments to any previously filed annual report may be filed with  
24 the Secretary of State at any time for the purpose of correcting, updating, or augmenting the  
25 information contained in the annual report.

27 (g) Effective Date for Certain Statements of Change. – When a statement of change of  
28 registered office or registered agent is filed in the annual report, the change shall become effective  
29 when the statement is received by the Secretary of State.

30 (h) Delinquency. – If the Secretary of State does not receive an annual report within ~~120~~  
31 60 days of the date the ~~return~~ report is due, the Secretary of State may presume that the annual  
32 report is delinquent. This presumption may be rebutted ~~by receipt of the annual report from the~~  
33 ~~Secretary of Revenue or by evidence~~ satisfactory to the Secretary of State of delivery submission  
34 presented by the filing corporation.

35 (i) E-Mail; Confidentiality. – The Secretary of State may provide by e-mail any notice or  
36 form required under this section if the submitting domestic or foreign corporation to be notified  
37 has consented to receiving notices and forms via e-mail and has provided the Secretary of State an  
38 e-mail address for receiving the notices or forms. Any e-mail address provided by a submitting  
39 domestic or foreign corporation in accordance with this section shall be considered confidential  
40 information and shall not be subject to disclosure under Chapter 132 of the General Statutes."

41 **SECTION 2.** G.S. 55-14-22(b) reads as rewritten:

42 "(b) If the Secretary of State determines that the application contains the information  
43 required by subsection (a) of this section, that the information is correct, ~~and~~ that the name of the  
44 corporation complies with G.S. 55D-21 and any other applicable section, and that any penalties,  
45 fees, or other payments due under this Chapter have been paid, the Secretary of State shall cancel  
46 the certificate of dissolution and prepare a certificate of reinstatement that recites the Secretary of  
47 State's determination and the effective date of reinstatement, file the original of the certificate, and  
48 mail a copy to the corporation."

49 **SECTION 3.** G.S. 55-1-22 reads as rewritten:

50 "**§ 55-1-22. Filing, service, and copying fees.**

8 (d) The fee for the annual report in subdivision ~~(23)~~ (23a) of subsection (a) of this section  
 9 is nonrefundable. Notwithstanding any provision of law to the contrary, the State Treasurer shall  
 10 remit the sum of two dollars (\$2.00) of each fee collected under subdivision (23a) of subsection  
 11 (a) of this section to the Secretary of State to be used for the purpose set forth in G.S. 66-58.12(c).  
 12 Any funds received under this subsection are hereby appropriated for the purpose designated in  
 13 this subsection.

14 (e) Notwithstanding G.S. 147-86.22(b) or any other provision of law to the contrary, and  
 15 with respect to the submission of an annual report required under G.S. 55-16-22, the Secretary of  
 16 State shall not charge an additional amount for the use of electronic filing, electronic payment, or  
 17 electronic filing and payment."

18 **SECTION 4.** G.S. 57D-2-24 reads as rewritten:

20 (a) Requirement. – Excluding professional limited liability companies governed by  
 21 G.S. 57D-2-02, each LLC and each foreign LLC authorized to transact business in this State ~~must~~  
 22 ~~deliver~~ shall submit an annual report to the Secretary of State for filing annual reports on a in  
 23 electronic form as prescribed by, and in the manner required by, by the Secretary of State and as  
 24 otherwise provided in ~~subsection~~ subsections (b) and (b1) of this section. Each annual report must  
 25 specify the year for which the report applies and provide the information required by this  
 26 subsection. The information must be current as of the date the limited liability company completes  
 27 the report. ~~If the information in the limited liability company's most recent annual report has not~~  
 28 ~~changed, the limited liability company may certify in its annual report that the information has not~~  
 29 ~~changed in lieu of restating the information.~~

30 (a1) Required Information. – The following information must be included in each annual  
 31 report:

- 32 (1) The name of the limited liability company and, in the case of a foreign LLC,  
 33 any different name that the foreign LLC is authorized under Article 3 of  
 34 Chapter 55D of the General Statutes to use to transact business in this State, as  
 35 provided in the foreign LLC's certificate of authority.
- 36 (2) In the case of a foreign LLC, the name of the jurisdiction under whose law the  
 37 foreign LLC is organized.
- 38 (3) The street address, and the mailing address if different from the street address,  
 39 of the limited liability company's registered office in the State, the county in  
 40 which the registered office is located, the name and e-mail address of its  
 41 registered agent at that office, and a statement of any change of the registered  
 42 office or registered agent.
- 43 (4) The address and telephone number of its principal office.
- 44 (5) The names, titles, and physical business addresses of the limited liability  
 45 company's principal company officials, managers and other company officials  
 46 who have actual authority to bind the limited liability company.
- 47 (6) A brief description of the nature of its business.
- 48 (7) A valid e-mail address for the limited liability company, if different from the  
 49 e-mail address provided under subdivision (3) of this subsection.

50 (b) Due Date for Initial Annual Report. – The Secretary of State must notify limited  
 51 liability companies of the annual report filing requirement. The first annual report of a limited

1 liability company is due to be ~~delivered~~submitted to the Secretary of State by April 15 of the year  
 2 following (i) in the case of an LLC, the calendar year in which the LLC's articles of organization  
 3 or articles of organization and conversion filed by the Secretary of State become effective or (ii) in  
 4 the case of a foreign LLC, the calendar year in which the Secretary of State issues to the foreign  
 5 LLC a certificate of authority to transact business in this State.

6 (b1) Due Date for Subsequent Annual Reports. – The limited liability company shall ~~deliver~~  
 7 submit an annual report by April 15 of each subsequent year until (i) in the case of an LLC, the  
 8 effective date of its articles of dissolution filed by the Secretary of State or the effective date of  
 9 either a certificate of dissolution for an LLC that is not reinstated under G.S. 57D-6-06(c) or a  
 10 decree of dissolution that is filed by the Secretary of State as provided in G.S. 57D-6-05; (ii) in the  
 11 case of a foreign LLC, the foreign LLC receives a certificate of withdrawal from the Secretary of  
 12 State or the Secretary of State revokes the foreign LLC's certificate of authority under Part 3 of  
 13 Article 7 of this Chapter; or (iii) in the case of either an LLC or foreign LLC, the effective date of  
 14 a merger or conversion under Article 9 of this Chapter in which the limited liability company is a  
 15 merging entity or a converting entity but not the surviving entity.

16 (c) Incomplete Information; Civil Penalty; Criminal Penalty. – If an annual report does not  
 17 ~~contain the information required by this section, the Secretary of State shall promptly notify the~~  
 18 ~~reporting limited liability company in writing and return the report to it for correction. completely~~  
 19 ~~and accurately contain the information required under subdivisions (3) and (5) of subsection (a1)~~  
 20 ~~of this section, the Secretary of State may assess a penalty of two hundred fifty dollars (\$250.00).~~  
 21 In addition, any person who willfully fails to completely and accurately provide the information  
 22 required under subdivisions (3) and (5) of subsection (a1) of this section shall be punished the  
 23 same as in G.S. 55D-18. If the report is corrected to contain the information required by this  
 24 section and ~~delivered~~submitted, with payment of any penalty assessed under this subsection, to  
 25 the Secretary of State within 30 days after the effective date of notice, it is deemed to be timely  
 26 ~~delivered~~submitted.

27 (d) Amendments. – Amendments to any previously filed annual report may be ~~delivered~~  
 28 submitted for filing by the Secretary of State at any time for the purpose of correcting, updating, or  
 29 augmenting the information contained in the annual report.

30 (e) E-Mail; Confidentiality. – The Secretary of State may provide by e-mail any notice or  
 31 form required under this section if the submitting LLC to be notified has consented to receiving  
 32 notices and forms via e-mail and has provided the Secretary of State an e-mail address for  
 33 receiving the notices or forms. Any e-mail address provided by a submitting LLC in accordance  
 34 with this section shall be considered confidential information and shall not be subject to disclosure  
 35 under Chapter 132 of the General Statutes."

36 **SECTION 5.** G.S. 57D-1-22 reads as rewritten:

37 "**§ 57D-1-22. Filing, service, and copying fees.**

38 (a) The Secretary of State shall collect the following fees when the documents described in

47 (e) Notwithstanding any provision of law to the contrary, the State Treasurer shall remit

 49 this section to the Secretary of State to be used for the purpose set forth in G.S. 66-58.12(c). Any

6 (a) Requirement. – Each domestic corporation, and each foreign corporation authorized to  
7 conduct affairs in this State, shall submit an annual report to the Secretary of State in electronic  
8 form as prescribed by the Secretary of State that sets forth all of the following:

- 9 (1) The name of the corporation and the state or country under whose law it is  
10 incorporated.
- 11 (2) The street address, and the mailing address if different from the street address,  
12 of the registered office, the county in which its registered office is located, the  
13 name and e-mail address of its registered agent at that office in this State, and a  
14 statement of any change of the registered office or registered agent.
- 15 (3) The address and telephone number of its principal office.
- 16 (4) The names, titles, and physical business addresses of its officers who have  
17 actual authority to bind the corporation.
- 18 (5) A brief description of the nature of its activities.
- 19 (6) Whether or not it has members.
- 20 (7) A valid e-mail address for the corporation, if different from the e-mail address  
21 provided under subdivision (2) of this subsection.

22 (b) Currency of Information. – The information in the annual report shall be current as of  
23 the date the annual report is executed on behalf of the corporation.

24 (c) Due Date. – The first annual report of the corporation shall be submitted to the  
25 Secretary of State by May 15 of the year following formation. The corporation shall submit  
26 subsequent annual reports to the Secretary of State by May 15.

27 (d) Incomplete Information; Civil Penalty; Criminal Penalty. – If an annual report does not  
28 completely and accurately contain the information required under subdivisions (2) and (4) of  
29 subsection (a) of this section, the Secretary of State may assess a penalty of two hundred fifty  
30 dollars (\$250.00). In addition, any person who willfully fails to completely and accurately provide  
31 the information required under subdivisions (2) and (4) of subsection (a) of this section shall be  
32 punished the same as in G.S. 55D-18. If the report is corrected to contain the information required  
33 by this section and submitted to the Secretary of State within 30 days after the effective date of

 34 or electronic filing and payment."

25 shall be punished the same as in G.S. 55D-18. If the report is corrected to contain the information  
26 required by this section and ~~delivered~~ submitted, with payment of any penalty assessed under this

36 partnership has not paid, within 60 days after they are due, any penalties, fees,  
37 or other payments due under this ~~Chapter;~~ Chapter.

38 (2) The registered limited liability partnership or foreign limited liability  
39 partnership does not ~~deliver~~ submit its annual report to the Secretary of State on  
40 or before the ~~date~~ sixtieth day after it is due; due.

41 (3) The registered limited liability partnership or foreign limited liability  
42 partnership has been without a registered agent or registered office in this State  
43 for 60 days or ~~more;~~ or more.

44 (4) The registered limited liability partnership or foreign limited liability  
45 partnership does not notify the Secretary of State within 60 days of the change,  
46 resignation, or discontinuance that its registered agent or registered office has  
47 been changed, that its registered agent has resigned, or that its registered office  
48 has been discontinued.

49 (g) Revocation Process. – If the Secretary of State determines that one or more grounds  
50 exist under subsection (f) of this section for revoking the registration of the registered limited  
51 liability partnership or foreign limited liability partnership, the Secretary of State shall mail the

1 registered limited liability partnership or foreign limited liability partnership written notice of that  
2 determination. If, within 60 days after the notice is mailed, the registered limited liability  
3 partnership or foreign limited liability partnership does not correct each ground for revocation or  
4 demonstrate to the reasonable satisfaction of the Secretary of State that each ground does not exist,  
5 the Secretary of State shall revoke the registration of a registered limited liability partnership or  
6 foreign limited liability partnership by signing a certificate of revocation that recites the ground or  
7 grounds for revocation and its effective date. The Secretary of State shall file the original  
8 certificate of revocation and mail a copy to the registered limited liability partnership or foreign  
9 limited liability partnership.

10 (h) Application for Reinstatement. – A registered limited liability partnership or foreign  
11 limited liability partnership whose registration is revoked under this section may apply to the  
12 Secretary of State for reinstatement. If, at the time the registered limited liability partnership  
13 applies for reinstatement, the name of the registered limited liability partnership is not  
14 distinguishable from the name of another entity authorized to be used under G.S. 55D-21, then the  
15 registered limited liability partnership must change its name to a name that is distinguishable upon  
16 the records of the Secretary of State from the name of the other entity before the Secretary of State  
17 may prepare a certificate of reinstatement. The procedures for reinstatement and for the appeal of  
18 any denial of the registered limited liability partnership or foreign limited liability partnership's  
19 application for reinstatement shall be the same procedures applicable to business corporations  
20 under G.S. 55-14-22, 55-14-23, and 55-14-24. The effect of reinstatement of a limited liability  
21 partnership shall be the same as for a corporation under G.S. 55-14-22.

25 and has provided the Secretary of State an e-mail address for receiving the notices or forms. Any  
26 e-mail address provided by a submitting registered limited liability partnership or foreign limited  
27 liability partnership in accordance with this section shall be considered confidential information  
28 and shall not be subject to disclosure under Chapter 132 of the General Statutes."

29 **SECTION 12.** G.S. 59-35.2 reads as rewritten:

38           share with one another, upon request and to the extent permitted by federal law, information that is  
39           in their possession that is relevant to verifying whether an applicant for a refund under

45           (a) Any corporation or limited liability company whose articles of incorporation, articles  
46           of organization, or certificate of authority to do business in this State has been suspended by the  
47           Secretary of State under G.S. 105-230, that complies with all the requirements of this Subchapter  
48           and pays all State taxes, fees, or penalties due from it (which total amount due may be computed,  
49           for years prior and subsequent to the suspension, in the same manner as if the suspension had not  
50           taken place), and pays to the Secretary of Revenue a fee of ~~twenty five~~ fifty dollars (~~\$25.00~~)  
51           (\$50.00) to cover the cost of reinstatement, is entitled to exercise again its rights, privileges, and

1 franchises in this State. The Secretary of Revenue shall notify the Secretary of State of this  
2 compliance and the Secretary of State shall reinstate the corporation or limited liability company  
3 by appropriate entry upon the records of the office of the Secretary of State. Upon entry of  
4 reinstatement, it relates back to and takes effect as of the date of the suspension by the Secretary of  
5 State and the corporation or limited liability company resumes carrying on its business as if the  
6 suspension had never occurred, subject to the rights of any person who reasonably relied, to that  
7 person's prejudice, upon the suspension. The Secretary of State shall immediately notify by mail  
8 the corporation or limited liability company of the reinstatement.

9 (a1) The Secretary of Revenue shall remit twenty-five dollars (\$25.00) from each fee  
10 collected under subsection (a) of this section to the Secretary of State to be used solely to cover its  
11 share of the cost of reinstatement under subsection (a) of this section, and any funds received  
12 under this subsection are hereby appropriated for the maximum amount necessary to achieve this  
13 purpose. Any funds received by the Secretary of State under this subsection that are in excess of  
14 the amount needed to cover the Secretary of State's share of the cost of reinstatement under  
15 subsection (a) of this section shall revert to the General Fund.

17 **SECTION 17.** The Joint Legislative Program Evaluation Oversight Committee shall  
18 amend the 2018-2019 Program Evaluation Division work plan to direct the Program Evaluation  
19 Division to study the effect implementation of this act will have on the staffing levels and  
20 customer service demands at the Office of the Secretary of State and the Department of Revenue.  
21 The Program Evaluation Division shall report the results of the study to the chairs of the Joint  
22 Legislative Program Evaluation Oversight Committee and the Joint Legislative Oversight  
23 Committee on General Government on or before August 1, 2019.

24 **SECTION 18.** Sections 1 through 5 and 10 through 12 of this act become effective  
25 January 1, 2018, and apply to annual reports due on or after that date. Section 13 of this act  
26 becomes effective January 1, 2018. Sections 6 through 9 and Section 14 of this act become  
27 effective January 1, 2019. Section 16 of this act is effective when it becomes law and applies to  
28 fees collected on or after that date. The remainder of this act is effective when it becomes law.
