3 The General Assembly of North Carolina enacts:

5 **PART I. BUSINESS TAX CHANGES**

6 **SECTION 1.1.** G.S. 105-114 reads as rewritten:

7 "**§ 105-114. Nature of taxes; definitions.**

8 (a) ~~Nature of Taxes. The taxes levied in this Article upon persons and partnerships are~~
9 ~~for the privilege of engaging in business or doing the act named.~~

10 (a1) ~~Scope. – The taxes-tax levied in this Article upon corporations are-is a privilege or~~
11 ~~exercise taxes-tax levied upon:~~

12 (1) Corporations organized under the laws of this State for the existence of the
13 corporate rights and privileges granted by their charters, and the enjoyment,
14 under the protection of the laws of this State, of the powers, rights, privileges
15 and immunities derived from the State by the form of such existence; and

16 (2) Corporations not organized under the laws of this State for doing business in
17 this State and for the benefit and protection which these corporations receive
18 from the government and laws of this State in doing business in this State.

19 (a2) ~~Condition for Doing Business. – If the corporation is organized under the laws of~~
20 ~~this State, the payment of the taxes-tax levied by this Article is a condition precedent to the~~
21 ~~right to continue in the corporate form of organization. If the corporation is not organized under~~
22 ~~the laws of this State, payment of these taxes-this tax is a condition precedent to the right to~~
23 ~~continue to engage in doing business in this State.~~

24 (a3) ~~Tax Year. – The taxes-tax levied in this Article are-is for the fiscal year of the State~~
25 ~~in which the taxes become due, except that the taxes levied in G.S. 105-122 are for the income~~
26 ~~year of the corporation in which the taxes become due.~~

27 (a4) ~~No Double Taxation. – G.S. 105-122 does not apply to holding companies taxed~~
28 ~~under G.S. 105-120.2. G.S. 105-122 applies to a corporation taxed under another section of this~~
29 ~~Article only to the extent the taxes levied on the corporation in G.S. 105-122 exceed the taxes~~
30 ~~levied in other sections of this Article on the corporation or on a limited liability company~~
31 ~~whose assets must be included in the corporation's tax base under G.S. 105-114.1.~~

33 **SECTION 1.2.** G.S. 105-120.2(c) reads as rewritten:



1 "(c) For purposes of this section, a "holding company" is a corporation that satisfies at
2 least one of the following conditions:

4 (2) It receives during its taxable year more than eighty percent (80%) of its
5 gross income from corporations in which it owns directly or indirectly more
6 than fifty percent (50%) of the outstanding voting ~~stock or stock~~, voting
7 capital ~~interests~~, interests, or ownership interests."

8 **SECTION 1.3.(a)** G.S. 105-122 reads as rewritten:

9 **"§ 105-122. Franchise or privilege tax on domestic and foreign corporations.**

10 (a) Tax Imposed. – An annual franchise or privilege tax is imposed on a corporation
11 doing business in this ~~State~~. State for the privilege of doing business in this State and for the
12 continuance of articles of incorporation or domestication of each corporation in this State. The
13 tax is determined on the basis of the books and records of the corporation as of the close of its
14 income year. A corporation subject to the tax must file a return under affirmation with the
15 Secretary at the place and in the manner prescribed by the Secretary. The return must be signed
16 by the president, vice-president, treasurer, or chief financial officer of the corporation. The
17 return is due on or before the fifteenth day of the fourth month following the end of the
18 corporation's income year.

20 (d) ~~Tax Base and Tax Rate. – After determining the Base. – A corporation's tax base is~~
21 the greatest of the following:

- 22 (1) The proportion of its net worth as set out in subsection (c1) of this section,
23 which amount shall not be less than fifty five percent (55%) section.
24 (2) Fifty-five percent (55%) of the corporation's appraised value as determined
25 for ad valorem taxation of all the real and tangible personal property in this
26 State of each corporation nor less than its State. For purposes of this
27 subdivision, the appraised value of tangible property, including real estate, is
28 the ad valorem valuation for the calendar year next preceding the due date of
29 the franchise tax return.
30 (3) The corporation's total actual investment in tangible property in this State,
31 every corporation taxed under this section shall annually pay to the Secretary
32 of Revenue, at the time the return is due, a franchise or privilege tax at the
33 rate of one dollar and fifty cents (\$1.50) per one thousand dollars (\$1,000) of
34 the total amount of net worth as provided in this section. The tax imposed in
35 this section shall not be less than two hundred dollars (\$200.00) and is for
36 the privilege of carrying on, doing business, and/or the continuance of
37 articles of incorporation or domestication of each corporation in this State.
38 Appraised value of tangible property including real estate is the ad valorem
39 valuation for the calendar year next preceding the due date of the franchise
40 tax return. The term "total State. For purposes of this subdivision, the total
41 actual investment in tangible property" as used in this section means
42 property in this State is the total original purchase price or consideration to
43 the reporting taxpayer of its tangible properties, including real estate, in this
44 State plus additions and improvements thereto less (i) reserve for
45 depreciation as permitted for income tax purposes.purposes and (ii) any
46 indebtedness specifically incurred and existing solely for and as the result of
47 the purchase of any real estate and any permanent improvements made on
48 the real estate.

1 (d2) Tax Rate. – The tax rate is one dollar and fifty cents (\$1.50) per one thousand
 2 dollars (\$1,000) of the corporation's tax base as determined under subsection (d) of this section.
 3 The tax imposed in this section shall not be less than two hundred dollars (\$200.00).

5 **SECTION 1.3.(b)** This section becomes effective for taxable years beginning on or
 6 after January 1, 2020, and is applicable to the calculation of franchise tax reported on the 2019
 7 and later corporate income tax returns.

8 **SECTION 1.4.(a)** G.S. 105-129.106(b) reads as rewritten:

9 "(b) Limitations. – The amount of credit allowed under this section with respect to
 10 rehabilitation expenses for a non-income-producing certified historic structure may not exceed
 11 twenty-two thousand five hundred dollars (\$22,500) per discrete property parcel. In the event
 12 that the taxpayer is the transferee of a State-certified historic structure for which rehabilitation
 13 expenses were made, the taxpayer as transferee is allowed a credit under this section for the
 14 rehabilitation expenses made by the transferor only if the transfer takes place before the
 15 structure is placed in service. In this event, ~~no~~ the transferor must provide the transferee with
 16 documentation detailing the amount of rehabilitation expenses and credit. No other taxpayer
 17 may claim such credit. A taxpayer is allowed to claim a credit under this section no more than
 18 once in any five-year period, carryovers notwithstanding."

 31 employment, development, or disposition of the property is or was
 32 related to the operation of the taxpayer's trade or business.

33 (2) Business activity. – Any activity by a corporation that would establish
 34 nexus, except as limited by 15 U.S.C. § 381.

35 (3) Casual sale of property. – The sale of any property that was not purchased,
 36 produced, or acquired primarily for sale in the corporation's regular trade or
 37 business.

~~Federal Communications Commission, the Federal Energy Regulatory Commission, or the Federal Aviation Agency; and that owns or operates for public use any plant, equipment, property, franchise, or license for the transmission of communications, the transportation of goods or persons, or the production, storage, transmission, sale, delivery or furnishing of electricity, water, steam, oil, oil products, or gas. The term also includes a motor carrier of property whose principal business activity is transporting property by motor vehicle for hire over the public highways of this State.~~

(7) ~~"Sales" means all Sales. – All gross receipts of the corporation except for the following receipts:~~

(8) ~~"Casual sale of property" means the sale of any property which was not purchased, produced or acquired primarily for sale in the corporation's regular trade or business.~~

~~(9)~~(8) ~~"State" means any State. – A state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, any territory or possession of the United States, and any foreign country or political subdivision thereof.~~

(b) Multistate Corporations. – A corporation having income from business activity which is taxable both within and without this State shall allocate and apportion its net income or net loss as provided in this section. For purposes of allocation and apportionment, a corporation is taxable in another state if ~~(i) the~~ either of the following applies:

(1) The corporation's business activity in that state subjects it to a net income tax or a tax measured by net income, or (ii) that income.

(2) That state has jurisdiction based on the corporation's business activity in that state to subject the corporation to a tax measured by net income regardless whether that state exercises its jurisdiction. For purposes of this section, "business activity" includes any activity by a corporation that would establish a taxable nexus pursuant to 15 United States Code section 381.

(c) Nonapportionable Income. – Rents and royalties from real or tangible personal property, gains and losses, interest, dividends, patent and copyright royalties and other kinds of income, to the extent that they constitute nonapportionable income, less related expenses shall be allocated as provided in subsections (d) through (h) of this section.

(d) Rents and Royalties. – Net rents and royalties are allocable to this State as follows:

(e) Gains and Losses. – Gains and losses are allocable to this State as follows:

(f) Interest and Net Dividends. – Interest and net dividends are allocable to this State if the corporation's commercial domicile is in this State. For purposes of this section, the term "net dividends" means gross dividend income received less related expenses.

(g) Intangible Property. – Intangible property is allocable to this State as follows:

~~...~~

(h) Other Income. – The income less related expenses from any other activities producing nonapportionable income or investments not otherwise specified in this section is allocable to this State if the business situs of the activities or investments is located in this State.

(m) Railroad Company. – All apportionable income of a railroad company shall be apportioned to this State by multiplying the income by a fraction, the numerator of which is the "railway operating revenue" from business done within this State and the denominator of which is the "total railway operating revenue" from all business done by the company as shown by its

1 records kept in accordance with the standard classification of accounts prescribed by the
2 Interstate Commerce Commission, generally accepted accounting principles.

3 ~~"Railway operating revenue" from business done within this State shall mean "railway~~
4 ~~operating revenue" from business wholly within this State, plus the equal mileage proportion~~
5 ~~within this State of each item of "railway operating revenue" received from the interstate~~
6 ~~business of the company. "Equal mileage proportion" shall mean the proportion which the~~
7 ~~distance of movement of property and passengers over lines in this State bears to the total~~
8 ~~distance of movement of property and passengers over lines of the company receiving such~~
9 ~~revenue. "Interstate business" shall mean "railway operating revenue" from the interstate~~
10 ~~transportation of persons or property into, out of, or through this State. If the Secretary of~~
11 ~~Revenue finds, with respect to any particular company, that its accounting records are not kept~~
12 ~~so as to reflect with exact accuracy such division of revenue by State lines as to each~~
13 ~~transaction involving interstate revenue, the Secretary of Revenue may adopt such regulations,~~
14 ~~based upon averages, as will approximate with reasonable accuracy the proportion of interstate~~
15 ~~revenue actually earned upon lines in this State. Provided, that where a railroad is being~~
16 ~~operated by a partnership which is treated as a corporation for income tax purposes and pays a~~
17 ~~net income tax to this State, or if located in another state would be so treated and so pay as if~~
18 ~~located in this State, each partner's share of the net profits shall be considered as dividends paid~~
19 ~~by a corporation for purposes of this Part and shall be so treated for inclusion in gross income,~~
20 ~~deductibility, and separate allocation of dividend income.~~

21 The following definitions apply in this subsection:

22 (1) Equal mileage proportion. – The proportion which the distance of movement
23 of property and passengers over lines in this State bears to the total distance
24 of movement of property and passengers over lines of the company
25 receiving such revenue.

26 (2) Interstate business. – Railroad operating revenue from the interstate
27 transportation of persons or property into, out of, or through this State.

28 (3) Railway operating revenue from business done within this State. – Railroad
29 operating revenue from business wholly within this State, plus the equal
30 mileage proportion within this State of each item of railway operating
31 revenue received from the interstate business of the company.

32 (n) ~~All apportionable income of a telephone company shall be apportioned to this State~~
33 ~~by multiplying the income by a fraction, the numerator of which is gross operating revenue~~
34 ~~from local service in this State plus gross operating revenue from toll services performed~~
35 ~~wholly within this State plus the proportion of revenue from interstate toll services attributable~~
36 ~~to this State as shown by the records of the company plus the gross operating revenue in North~~
37 ~~Carolina from other service less the uncollectible revenue in this State, and the denominator of~~
38 ~~which is the total gross operating revenue from all business done by the company everywhere~~
39 ~~less total uncollectible revenue. Provided, that where a telephone company is required to keep~~
40 ~~its records in accordance with the standard classification of accounts prescribed by the Federal~~
41 ~~Communications Commission the amounts in such accounts shall be used in computing the~~
42 ~~apportionment fraction as provided in this subsection.~~

43 (o) Motor Carrier. – All apportionable income of a motor carrier of property or a motor
44 carrier of people shall be apportioned by multiplying the income by a fraction, the numerator of
45 which is the number of vehicle miles in this State and the denominator of which is the total
46 number of vehicle miles of the company everywhere. The words "vehicle miles" shall mean
47 miles traveled by vehicles owned or operated by the company based upon one of the following:

48 (1) Miles on a scheduled route.

49 (2) Miles hauling property for a charge or traveling on a scheduled route charge.

50 (3) Miles carrying passengers for a fare.

~~(p) All apportionable income of a motor carrier of passengers shall be apportioned by multiplying the income by a fraction, the numerator of which is the number of vehicle miles in this State and the denominator of which is the total number of vehicle miles of the company everywhere. The words "vehicle miles" shall mean miles traveled by vehicles owned or operated by the company carrying passengers for a fare or traveling on a scheduled route.~~

~~(q) All apportionable income of a telegraph company shall be apportioned by multiplying the income by a fraction, the numerator of which is the property factor plus the payroll factor plus the sales factor and the denominator of which is three.~~

~~The property factor shall be as defined in subsection (j) of this section, the payroll factor shall be as defined in subsection (k) of this section, and the sales factor shall be as defined in subsection (l) of this section.~~

(r) All apportionable income of an excluded corporation and of all other public utilities shall be apportioned by multiplying the income by the sales factor as determined under subsection (l) of this section.

The following definitions apply in this subsection:

(1) Excluded corporation. – Any corporation engaged in business as a building or construction contractor, a securities dealer, or a loan company or a corporation that receives more than fifty percent (50%) of its ordinary gross income from intangible property.

(2) Public utility. – Any corporation that is subject to control of one or more of the following entities: the North Carolina Utilities Commission, the Federal Communications Commission, the Federal Energy Regulatory Commission, or the Federal Aviation Agency; and that owns or operates for public use any plant, equipment, property, franchise, or license for the transmission of communications, the transportation of goods or persons, or the production, storage, transmission, sale, delivery, or furnishing of electricity, water, steam, oil, oil products, or gas. The term also includes a motor carrier of property whose principal business activity is transporting property by motor vehicle for hire over the public highways of this State.

(s) Transportation Corporation. – All apportionable income of an air transportation corporation or a water transportation corporation shall be apportioned by a fraction, the numerator of which is the corporation's revenue ton miles in this State and the denominator of which is the corporation's revenue ton miles everywhere. A qualified air freight forwarder shall use the revenue ton mile fraction of its affiliated air carrier. The following definitions apply in this subsection:

(s2) Pipeline Company. – Receipts from transportation of a petroleum-based liquids pipeline company shall be apportioned by multiplying the income by a fraction, the numerator of which is the number of barrel miles in this State during the tax year and the denominator of which is the total number of barrel miles everywhere during the tax year. For purposes of this section, the term "barrel mile" means one barrel of liquid property transported one mile.

SECTION 1.5.(b) This section is effective for taxable years beginning on or after January 1, 2017.

SECTION 1.6.(a) G.S. 105-130.7B(b)(1) is repealed.

SECTION 1.6.(b) G.S. 105-130.7B(b) reads as rewritten:

"(b) **Definitions.** – The definitions in G.S. 105-130.7A apply in this section. In addition, the following definitions apply in this section:

(3a) **Proportionate share of interest.** – The amount of taxpayer's net interest expense paid or accrued directly to or through a related member to an

1 ultimate payer divided by the total net interest expense of all related
 2 members that is paid or accrued directly to or through a related member to
 3 the same ultimate payer, multiplied by the interest paid or accrued to a
 4 person who is not a related member by the ultimate payer. Any amount that
 5 is distributed, paid, or accrued directly or through a related member that is
 6 not treated as interest under this Part does not qualify. In determining
 7 whether a nominal debt instrument creates deductible interest allowable

19 **SECTION 1.6.(c)** This section is effective for taxable years beginning on or after
 20 January 1, 2017.

21 **SECTION 1.7.(a)** G.S. 105-131.5 reads as rewritten:

22 "**§ 105-131.5. Part-year resident shareholder.**

23 If a shareholder of an S Corporation is both a resident and nonresident of this State during
 24 any taxable period, the shareholder's pro rata share of the S Corporation's income attributable to
 25 the State and income not attributable to the State for the taxable period shall be further prorated
 26 between the shareholder's periods of residence and nonresidence, in accordance with the
 27 number of days in each period, as provided in ~~G.S. 105-134.5.~~G.S. 105-153.4."

28 **SECTION 1.7.(b)** This section is effective for taxable years beginning on or after
 29 January 1, 2014.

30 **SECTION 1.8.** G.S. 105-131.7(a) reads as rewritten:

25 file a return under the Code shall file an information return when requested to do so by the
26 Secretary. The information return shall contain all information required by the Secretary. It
27 shall state specifically the items of the partnership's gross income, the deductions allowed under
28 the Code, each partner's distributive share of the partnership's income, and the adjustments
29 required by this Part. A partner's distributive share of partnership net income includes any
30 guaranteed payments made to the partner. The information return shall also include the name
31 and address of each person who would be entitled to share in the partnership's net income, if
32 distributable, and the amount each person's distributive share would be. ~~The information return~~
33 ~~shall specify the part of each person's distributive share of the net income that represents~~
34 ~~corporation dividends.~~ The information return shall be signed by one of the partners under
35 affirmation in the form required by the Secretary.

36 A partnership that files an information return under this subsection shall furnish to each
37 person who would be entitled to share in the partnership's net income, if distributable, any
38 information necessary for that person to properly file a State income tax return. The
39 information shall be in the form prescribed by the Secretary and must be furnished on or before
40 the due date of the information return.

41 (d) Payment of Tax on Behalf of Nonresident Owner or Partner. – If a business
42 conducted in this State is owned by a nonresident individual or by a partnership having one or
43 more nonresident members, the manager of the business shall report information concerning
44 the earnings of the business in this State, the distributive share of the income of each
45 nonresident owner or partner, and any other information required by the Secretary. The
46 distributive share of the income of each nonresident partner includes any guaranteed payments
47 made to the partner. The manager of the business shall pay with the return the tax on each
48 nonresident owner or partner's share of the income computed at the rate levied on individuals
49 under G.S. 105-153.7. The business may deduct the payment for each nonresident owner or

50 **SECTION 2.4.(c)** G.S. 105-164.6(b) reads as rewritten:

"(b) Liability. – The tax imposed by this section is payable by the person who purchases, leases, or rents tangible personal property or digital property or who purchases a service. If the property purchased becomes a part of a ~~building or other structure~~ real property in the State and ~~the purchaser is a contractor or subcontractor,~~ State, the real property contractor, the retailer-contractor, the subcontractor, the lessee, and the owner ~~of the building~~ are jointly and severally liable for the ~~tax,~~ tax, except as provided in G.S. 105-164.4H(a) regarding receipt of an affidavit of capital improvement. The liability of a real property contractor, a retailer-contractor, a subcontractor, a lessee, or an owner who did not purchase the property is satisfied by receipt of an affidavit from the purchaser certifying that the tax has been paid."

SECTION 2.4.(d) G.S. 105-164.15A(a)(2) reads as rewritten:

"(a) General Rate Items. – The effective date of a tax change for tangible personal property, digital property, or services taxable under this Article is administered as follows:

(2) For a taxable item that is not billed on a monthly or other periodic basis, a tax change applies to amounts received for items provided on or after the effective date, except amounts received for items ~~provided under a lump sum or unit price contract~~ purchased to fulfill a real property contract for a capital improvement entered into or awarded before the effective date or entered into or awarded pursuant to a bid made before the effective date."

SECTION 2.4.(e) G.S. 105-468.1 reads as rewritten:

 50 maintenance, and installation service to real property, the Secretary will allow the seller to
 51 offset the sales tax liability on the taxable repair, maintenance, and installation service with the

1 sales and use tax paid on the products provided the retailer can support the amount of tax
2 originally paid. A retailer entitled to a credit for tax originally paid under this provision may
3 reduce taxable receipts by the taxable amount of the credit for the period in which the credit

39 person and the charges are part of the gross receipts derived from the
40 rental of the accommodation taxed in accordance with

49 **SECTION 2.9.(b)** G.S. 105-164.14(b) reads as rewritten:

50 "(b) Nonprofit Entities and Hospital Drugs. – A nonprofit entity is allowed a semiannual
 51 refund of sales and use taxes paid by it under this Article on direct purchases of tangible

1 personal property and services for use in carrying on the work of the nonprofit entity. Sales and
2 use tax liability indirectly incurred by a nonprofit entity through reimbursement to an
3 authorized person of the entity for the purchase of tangible personal property and services for
4 use in carrying on the work of the nonprofit entity is considered a direct purchase by the entity.
5 Sales and use tax liability indirectly incurred by a nonprofit entity on building materials,
6 supplies, fixtures, and equipment that become a part of or annexed to any building or structure

15 following April 15. The aggregate annual refund amount allowed an entity under this

16 return to the ~~license holder~~licensee the bond filed by the ~~license holder~~licensee or notify the
17 person liable on the bond and the ~~license holder~~licensee that the person is released from
18 liability on the bond."

19 **SECTION 4.7.** G.S. 105-259(b) is amended by adding a new subdivision to read:

20 "(53) To provide to the Office of Child Support and Enforcement of the

2 issues unique to a specific agency.

3 (c) Participating Agencies. – The State CIO shall prepare detailed plans to transition
4 each of the participating agencies. As the transition plans are completed, the following
5 participating agencies shall transfer information technology personnel, operations, projects,
6 assets, and appropriate funding to the Department of Information Technology:

- 7 (1) Department of Natural and Cultural Resources.
- 8 (2) Department of Health and Human Services.
- 9 (3) Department of Revenue.
- 10 (4) Department of Environmental Quality.
- 11 (5) Department of Transportation.
- 12 (6) Department of Administration.
- 13 (7) Department of Commerce.
- 14 (8) Governor's Office.
- 15 (9) Office of State Budget and Management.
- 16 (10) Office of State Human Resources.
- 17 (11) Repealed by Session Laws 2016-94, s. 7.11(a), effective July 1, 2016.
- 18 (12) Department of Military and Veterans Affairs.
- 19 (13) Department of Public Safety, with the exception of the following:
 - 20 a. State Bureau of Investigation.
 - 21 b. State Highway Patrol.
 - 22 c. Division of Emergency Management.

23 The State CIO shall ensure that State agencies' operations are not adversely impacted during the
24 transition under the State agency information technology consolidation.

25 (d) Report on Transition Planning. – The Community College System Office-Office, the
26 Department of Public Instruction, the Department of Revenue, and the State Board of Elections
27 shall work with the State CIO to plan their transition to the Department. The information
28 technology transfer and consolidation from the Department of Revenue to the Department may
29 not take place until the system and data security of the Department meets the heightened
30 security standards required by the federal government for purposes of sharing taxpayer
31 information. By October 1, 2018, these agencies, in conjunction with the State CIO, shall report
32 to the Joint Legislative Oversight Committee on Information Technology and the Fiscal
33 Research Division on their respective transition plans.

34 (e) Separate agencies may transition their information technology to the Department
35 following completion of a transition plan."

36 **SECTION 4.9.** This part is effective when it becomes law and applies to requests
37 for review filed on or after that date and to requests for review pending on that date for which
38 the Department reissues a request for additional information, allows the taxpayer time to
39 respond by the requested response date, and provides notification to the taxpayer that failure to
40 timely respond to the request will result in the request for review being subject to the provisions
41 of G.S. 105-241.13A.

44 **SECTION 5.1.(a)** G.S. 105-330.3(a1) reads as rewritten:

47 vehicle is located on or before January 31 following the date the owner acquired the

49 the date the registration expires, and on or before January 31 of each succeeding year that the
50 vehicle is unregistered. If a classified motor vehicle required to be listed pursuant to this

- 4 (2) For any months for which the vehicle was not taxed between the date the
 5 registration expired and the start of the current registered vehicle tax year,
 6 the vehicle is taxed as an unregistered vehicle as follows:
- 7 a. The value of the motor vehicle is determined as of January 1 of the
 8 year in which ~~the registration of the motor vehicle expires.~~ the taxes
 9 are computed.
- 10 ...
- 11 d. The taxes are due on ~~the first day of the second month~~ September 1
 12 following the month date the notice was prepared. Taxes are payable
 13 at par or face amount if paid before January 6 following the due date.
 14 Taxes paid on or after January 6 following the due date are subject to
 15 interest charges. Interest accrues on taxes paid on or after January 6
 16 pursuant to G.S. 105-360.
- 17 e. ~~Interest accrues on unpaid taxes for these unregistered classified~~
 18 ~~motor vehicles at the rate of five percent (5%) for the remainder of~~
 19 ~~the month following the month the taxes are due. Interest accrues at~~
 20 ~~the rate of three fourths percent (3/4%) for each following month~~
 21 ~~until the taxes are paid, unless the notice is prepared after the date the~~
 22 ~~taxes are due. In that circumstance, the interest accrues beginning the~~
 23 ~~second month following the date of the notice until the taxes are~~
 24 ~~paid.~~

26 **SECTION 5.1.(b)** This section is effective for taxes imposed for taxable years
 27 beginning on or after July 1, 2017.

28 **SECTION 5.2.** G.S. 105-330.6(c) reads as rewritten:

29 "(c) Surrender of Plates. – If the owner of a classified motor ~~vehicle listed pursuant to~~
 30 ~~G.S. 105-330.3(a)(1) vehicle, who pays the tax as required by G.S. 105-330.4(a), either~~
 31 transfers the motor vehicle to a new owner or moves out-of-state and registers the vehicle in
 32 another jurisdiction, and the owner surrenders the registration plates from the listed vehicle to
 33 the Division of Motor Vehicles, then the owner may apply for a release or refund of taxes on
 34 the vehicle for any full calendar months remaining in the vehicle's tax year after the date of
 35 surrender. To apply for a release or refund, the owner must present to the county tax collector
 36 within one year after surrendering the plates the receipt received from the Division of Motor
 37 Vehicles accepting surrender of the registration plates. The county tax collector shall then
 38 multiply the amount of the taxes for the tax year on the vehicle by a fraction, the denominator

 42 refunded. If the taxes have not been paid at the date of application, the county tax collector
 43 shall make a release of the prorated taxes and credit the owner's tax notice with the amount of
 44 the release. If the taxes have been paid at the date of application, the county tax collector shall
 45 direct an order for a refund of the prorated taxes to the county finance officer, and the finance
 46 officer shall issue a refund to the vehicle owner."

47 **SECTION 5.3.** G.S. 105-338 reads as rewritten:

48 "**§ 105-338. Allocation of appraised valuation of public service property among local**
 49 **taxing units.**

50 (a) State Board's Duty. – For purposes of taxation by local taxing units in this State, the

 10 ~~event, however, shall the State Board make an allocation to a taxing unit if,~~
 11 ~~when computed, the valuation for that taxing unit amounts to less than five~~
 12 ~~hundred dollars (\$500.00).~~

14 **SECTION 5.4.(a)** G.S. 105-275 is amended by adding a new subdivision to read:

15 **"§ 105-275. Property classified and excluded from the tax base.**

16 The following classes of property are designated special classes under Article V, Sec. 2(2),
 17 of the North Carolina Constitution and are excluded from tax:

18 ...

19 (49) A mobile classroom or modular unit that is occupied by a school and is
 20 wholly and exclusively used for educational purposes, as defined in
 21 G.S. 105-278.4(f), regardless of the ownership of the property. For the
 22 purposes of this subdivision, the term "school" means a public school,
 23 including any school operated by a local board of education in a local school
 24 administrative unit; a nonprofit charter school; a regional school; a nonprofit
 25 nonpublic school regulated under Article 39 of Chapter 115C of the General
 26 Statutes; or a community college established under Article 2 of Chapter
 27 115D of the General Statutes."

28 **SECTION 5.4.(b)** This section is effective for taxes imposed for taxable years
 29 beginning on or after July 1, 2017.

30 **PART VI. OTHER CHANGES**

31 **SECTION 6.1.(a)** G.S. 159-32 reads as rewritten:

32 **"§ 159-32. Daily deposits.**

33 Except as otherwise provided by law, all taxes and other moneys collected or received by
 34 an officer or employee of a local government or public authority shall be deposited in
 35 accordance with this section. Each officer and employee of a local government or public
 36 authority whose duty it is to collect or receive any taxes or other moneys ~~shall~~ shall, on a daily
 37 basis, deposit his or submit to a properly licensed and recognized cash collection service all
 38 collections and receipts daily. If receipts. However, if the governing board gives its approval,
 39 deposits or submissions to a properly licensed and recognized cash collection service shall be
 40 required only when the moneys on hand amount to as much as two hundred fifty dollars
 41 (\$250.00), but in any event a deposit shall be made on the last business day of the month.
 42 (\$250.00) or greater. Until deposited or officially submitted to a properly licensed and
 43 recognized cash collection service, all moneys must be maintained in a secure location. All
 44 deposits shall be made with the finance officer or in an official depository. Deposits in an
 45 official depository shall be immediately reported to the finance officer by means of a duplicate
 46 deposit ticket. The finance officer may at any time audit the accounts of any officer or
 47 employee collecting or receiving taxes or other moneys, and may prescribe the form and detail
 48 of these accounts. The accounts of such an officer or employee shall be audited at least
 49 annually."

50 **SECTION 6.1.(b)** This section becomes effective October 1, 2017.
