1 A BILL TO BE ENTITLED  
2 AN ACT REMOVING THE CAP ON SATELLITE ANNEXATIONS FOR THE CITY OF  
3 ARCHDALE AND ADDING CERTAIN DESCRIBED PROPERTIES TO THE  
4 CORPORATE LIMITS OF THE CITY OF ASHEBORO.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. G.S. 160A-58.1 reads as rewritten:

7 "§ 160A-58.1. **Petition for annexation; standards.**

8 ...

9 (b) A noncontiguous area proposed for annexation must meet all of the following  
10 standards:

11 ...

12 (5) The area within the proposed satellite corporate limits, when added to the area  
13 within all other satellite corporate limits, may not exceed ten percent (10%)  
14 of the area within the primary corporate limits of the annexing city.

15 This subdivision does not apply to the Cities of Archdale, Asheboro,  
16 Belmont, Claremont, Concord, Conover, Durham, Elizabeth City, Gastonia,  
17 Greenville, Hickory, Kannapolis, Kings Mountain, Locust, Lowell, Marion,  
18 Mount Airy, Mount Holly, New Bern, Newton, Oxford, Randleman, Roanoke  
19 Rapids, Rockingham, Saluda, Sanford, Salisbury, Shelby, Southport,  
20 Statesville, and Washington and the Towns of Ahoskie, Angier, Apex, Ayden,  
21 Belville, Benson, Bladenboro, Bridgeton, Bunn, Burgaw, Calabash, Carthage,  
22 Catawba, China Grove, Clayton, Columbia, Columbus, Cramerton, Creswell,  
23 Dallas, Dobson, Four Oaks, Franklin, Franklinton, Franklinville,  
24 Fuquay-Varina, Garner, Godwin, Goldston, Granite Quarry, Green Level,  
25 Grimesland, Harrisburg, Holly Ridge, Holly Springs, Hookerton, Hope Mills,  
26 Huntersville, Jamestown, Kenansville, Kenly, Knightdale, Landis, Liberty,  
27 Lillington, Louisburg, Maggie Valley, Maiden, Mayodan, Maysville,

9               **SECTION 2.(b)** This section becomes effective June 30, 2023. Property in the  
10 territory described in this section as of January 1, 2023, is subject to municipal taxes for taxes  
11 imposed for taxable years beginning on or after July 1, 2023.

12               **SECTION 3.** Except as otherwise provided, this act is effective when it becomes  
13 law.
